

By our Authority, detailed in *The unanimous Declaration of the [fifty] united States of America*, originally signed in 1776, **with our consenting signatures the majority of the total number of registered voters** along with **the consenting signatures of other** resident-citizens who have not, as yet, registered a vote; We Ratify this 2018 Constitutional Convention's Constitution for our nation's government, "The United States of America"; *The 2018 Constitution for "The United States of America"* being the title for this Constitution.

On the date of ratification within the respective community (City/Town):

- the elected Legislative Branch for (City/Town) shall cease to exist
- (Insert Name for City Manager) and (Insert name for City Vice-Manager) shall take over the management of the governmental duties for (City/Town) in accord with *The 2018 Constitution for "The United States of America"*, so long as those duties do not violate the present 1787/90 Constitution for the United States of America's Supreme Law of the Land.

On the date of ratification within the respective community (County):

- the elected Legislative Branch for (County) shall cease to exist
- (Insert Name for County Manager) and (Insert name for County Vice-Manager) shall take over the management of the governmental duties for (County) in accord with *The 2018 Constitution for "The United States of America"*, so long as those duties do not violate the present 1787/90 Constitution for the United States of America's Supreme Law of the Land.

On the date of ratification within the respective community (State):

- the elected Legislative Branch for (State) shall cease to exist
- (Insert Name for State Governor) and (Insert name for State Vice-Governor) shall take over the management of the governmental duties for (State) in accord with *The 2018 Constitution for "The United States of America"*, so long as those duties do not violate the present 1787/90 Constitution for the United States of America's Supreme Law of the Land.

On the date of ratification within our nation's community (the united States of America):

- our nation's elected Legislative Branch shall cease to exist and *The 2018 Constitution for "The United States of America"* shall become fully enforceable across our nation in every level and branch of government
- (Daniel Melzine Kingery or until another Name for the New President of our Nation's Government "The United States of America") and (Insert name for New Vice-President of our Nation's Government "The United States of America") shall take over the management of the governmental duties for (City/Town) in accord with *The 2018 Constitution for "The United States of America"*, so long as those duties do not violate the present 1787/90 Constitution for the United States of America's Supreme Law of the Land.
